The role of the church and the mission in the state integration of the Northern borderless areas is also examined, as well as the new Lutheran clergy and their social and material conditions. In the third part, the visual and material expressions of the Reformation period is analyzed, as well as the encounter between the Catholic, the Lutheran and the Sámi religion.

In 1965 the International Union of the History and Philosophy of Science founded the Nicolas Copernicus Committee whose main task was to explore the means by which different nations could co-operate in celebrating the 5 centenary of the great scholar's birth. The committee initiated the publication of a collection of studies dealing with the effect that Copernicus' theory has had on scientific developments in centres of learning all over the world. An Editorial Board, consisting of J. Dobrzycki (Warsaw), J. R. Ravetz (Leeds), H. Sandblad (Goteborg) and B. Sticker (Hamburg), was nominated.
