vii Drugs and sex are two topics about which most people have strong opinions and weak understanding. Knowledge of each can be gained in many ways, all with associated rewards and risks. Like all textbooks, this one was written in the belief that reading can foster learning. The book is intended to introduce principles of behavioral pharmacology to readers with little or no knowledge of the discipline but with an interest in how drugs affect human behavior. Gleaning anything of value from the text requires two things from the reader. The first is a willingness to accept an analysis of drug effects that shares little with folklore or common sense notions of drug action. The second is a willingness to accept the fact that the behavioral effects of drugs are complex and depend upon a sizable number of pharmacological and behavioral variables. Unless one is aware of these factors and how they determine a drug's actions, the behavioral effects of drugs can be neither predicted nor meaningfully explained. If it does nothing else, this volume will make it obvious that the behavioral effects of drugs are lawful and can be predicted and understood on the basis of well-established relations between empirical phenomena. Describing these relations and exploring how they allow behavioral pharmacologists to make sense of drug effects that are otherwise incomprehensible was a major goal in preparing the text. America had a radically different relationship with drugs a century ago. Drug prohibitions were few, and while alcohol was considered a menace, the public regularly consumed substances that are widely demonized today. Heroin was marketed by Bayer Pharmaceuticals, and marijuana was available as a tincture of cannabis sold by Parke Davis and Company. Exploring how this rather benign relationship with psychoactive drugs was transformed into one of confusion and chaos, *The Cult of Pharmacology* tells the dramatic story of how, as one legal drug after another fell from grace, new pharmaceutical substances took their place. Whether Valium or OxyContin at the pharmacy, cocaine or meth purchased on the street, or alcohol and tobacco from the corner store, drugs and drug use proliferated in twentieth-century America despite an escalating war on "drugs." Richard DeGrandpre, a past fellow of the National Institute on Drug Abuse and author of the best-selling book *Ritalin Nation*, delivers a remarkably original interpretation of drugs by examining the seductive but ill-fated belief that they are chemically predestined to be either good or evil. Hart, Ziff Professor at Columbia University and former chair of the Department of Psychology, is one of the world's preeminent experts on the effects of so-called recreational drugs on the human mind and body. Dr. Hart is open about the fact that he uses drugs himself, in a happy balance with the rest of his full and productive life as a colleague, husband, father, and friend. In *Drug Use for Grown-Ups*, he draws on decades of research and his own personal experience to argue definitively that the criminalization and demonization of drug use--not drugs themselves--have been a tremendous scourge on America, not least in reinforcing this country's enduring structural racism. Dr. Hart did not always have this view. He came of age in one of Miami's most troubled neighborhoods at a time when many ills were being laid at the door of crack cocaine. His initial work as a researcher was aimed at proving that drug use caused bad outcomes. But one problem kept

cropping up: the evidence from his research did not support his hypothesis. From inside the massively well-funded research arm of the American war on drugs, he saw how the facts did not support the ideology. The truth was dismissed and distorted in order to keep fear and outrage stoked, the funds rolling in, and Black and brown bodies behind bars. Drug Use for Grown-Ups will be controversial, to be sure: the propaganda war, Dr. Hart argues, has been tremendously effective. Imagine if the only subject of any discussion about driving automobiles was fatal car crashes. Drug Use for Grown-Ups offers a radically different vision: when used responsibly, drugs can enrich and enhance our lives. We have a long way to go, but the vital conversation this book will generate is an extraordinarily important step.

Psychology: A Behavioral Overview is an introductory text with an orienting perspective that is frankly behavioral rather than eclectic. This focus is made quite clear in the first chapter of the book, but in the remainder it also becomes clear that such a focus permits coverage of most of the topics found in the more common introductory text. Actually, the next five chapters (dealing with psychology as a science, methodology, evolution, physiology, and learning) are in many ways comparable to the treatments provided in more eclectic introductory texts. The behavioral focus and the departure from traditional approaches become most significant in the last six chapters which deal with traditional psychological topics (e. g. , language, child development, and personality)-but deal with them systematically in terms of the concepts and principles introduced in the chapters on evolution and physiology, and especially in the chapter on learning. Using the concepts provided early in the text to interpret complex aspects of human behavior provides valuable justification for those concepts, as well as an opportunity for improved understanding of them. Although students will not make extensive contact with the variety of the theoretical approaches found in the typical text, they will become especially competent in the use of behavioral concepts and principles to interpret and understand many of the topics of traditional importance in psychology.

In recent years, there has been much debate over whether marijuana, an illegal drug, can provide patients with a level of therapeutic relief comparable to existing

pharmaceutical treatments. While this idea is hardly new, it is advanced by some proponents as deserving more scientific inquiry. Advocates for the medical use of marijuana contend that there is already sufficient scientific evidence to justify rescheduling marijuana under the Controlled Substances Act, a change that would give it the necessary legal recognition to be used for medicinal purposes. This has already occurred in the case of dronabinol, the synthetic form of the main psychoactive ingredient in marijuana, which has been available as an oral prescription drug since 1986 under its brand name Marinol. To address these viewpoints, several comprehensive studies were done in the late 1990s to evaluate medicinal claims made for smoked marijuana and determine whether they are supported by convincing scientific evidence. The medical marijuana debate gained attention at the state level in 1996, when voters in California and Arizona approved ballot initiatives allowing doctors to prescribe the drug for therapeutic uses. In 1998, similar propositions were adopted in Alaska, Nevada, Oregon, and Washington, and reaffirmed in Arizona. Voters in Maine adopted a medical marijuana initiative in 1999. In 2000, medical marijuana was approved by voters in Colorado, reconfirmed in Nevada, and passed by the legislature in Hawaii. Federal health officials assert that these initiatives are part of a strategy to soften the nation's drug laws, and that public policy would be better served if science, rather than the ballot box, were used to judge the drug's utility. This book assesses the current issues and examines the controversies regarding the marijuana legalization issue.
