

Estimating In Building Construction 7th Edition

In this study a project model for integrating building design, construction scheduling, and cost estimating at the preliminary design stage was developed and analyzed. The project model is developed in an object-oriented environment. The project model accepts a set of preliminary design parameters and generates an integrated schedule and cost estimate. The project model allows for interactive and iterative changes of design and construction plans, and allows for the evaluation of the impacts on the schedule and on the cost estimate due to these changes. The project model consists of an object-oriented system environment and a set of interactive and iterative processes. Seven major elements are designed in the object-oriented system environment: (1) Object Library; (2) Process Modules; (3) Blackboard; (4) Interactive Editors; (5) Project Scenario Files; (6) Historical Project Files; and (7) System Controller. The processes are (a) Design Initialization; (b) Initial Scheduling; (c) Detailed Scheduling; and (d) Cost Aggregation. The scope of this research is limited to mid-rise building construction. A prototype system of the project model was implemented on a personal computer using a windows-based, object-oriented programming environment, KAPPA-PCTM. The prototype system incorporates several external programs for various scheduling and financial analysis purposes.

Sub-contracting, the price of preliminaries, plan and specification contracts, and overheads, profit and project financing are each considered separately, with examples, in ; chapters 7 to 10. Chapter 11 considers the adjudication and bid submission process, while subsequent chapters deal with risk and uncertainty in estimating and tendering, bidding strategies, the client's view of the competitive bidding process, consortium and joint venture bidding, and the use of computers.

Building Construction Estimating furnishes readers with specific details on how a general building contractor derives the cost of a project before it begins, and how the estimate fits into the total construction process. The book provides coverage of such areas as determining labor productivity and wages, selecting equipment and assigning productivity rates and costs, acquiring specialty contractor prices, and assigning overhead costs and profit. The material is presented from the point of view of a general contractor working on a competitively bid stipulated-sum (lump-sum) contract. However, other contract methods and the effects they have on the estimating process are also discussed. Furthermore, the principles of estimating for the specialty trades are discussed from the reference of a general building contractor, and how the subcontractor's bid will affect the total project cost is presented. Of special note is the book's introduction and utilization of computers in the estimating process - enabling readers to utilize new technology in an effective and efficient manner. The book is organized in a way that first teaches the reader to perform many of the estimating activities manually, then guides them in developing a computer spreadsheet. The use of spreadsheets empowers the reader to go beyond the manual calculations and develop new and more proficient solutions to estimating problems.
