This anthology of folk and fairy tales brings together 52 stories from a range of historical and geographic traditions. Sections group tales together by theme or juxtapose variations of individual tales, inviting comparison and analysis across cultures and genres. An accessible section of critical selections provides a foundation for readers to analyze, debate, and interpret the tales for themselves. An expanded introduction by the editors looks at the history of folk and fairy tales and distinguishes between the genres, while revised introductions to individual sections provide more detailed history of particular tellers and tales, paying increased attention to the background and cultural origin of each tale. What happens to traditional stories when they are retold in another time and cultural context and for a different audience? This first-of-its-kind study discusses Bible stories, classical myths, heroic legends, Arthurian romances, Robin Hood lore, folk tales, 'oriental' tales, and other stories derived from European cultures. One chapter is devoted to various retellings of classics, from Shakespeare to "Wind in the Willows." The authors offer a general theory of what motivates the retelling of stories, and how stories express the aspirations of a society. An important function of stories is to introduce children to a cultural heritage, and to transmit a body of shared allusions and experiences that expresses a society's central values and assumptions. However, the cultural heritage may be modified through a pervasive tendency of retellings to produce socially conservative outcomes because of ethnocentric, androcentric and class-based assumptions in the source stories that persist into retellings. Therefore, some stories, such as classical myths, are particularly resistant to feminist reinterpretations, for example, while other types, such as folktales, are more malleable. In examining such possibilities, the book evaluates the processes of interpretation apparent in retellings. Index included.

George MacDonald occupied a major position in the intellectual life of his Victorian contemporaries. Whether one approaches the Bible from a perspective of faith, culture or literature, the power of the writing, the human situations, language and genres that make up the Scriptures speak potently across the ages. From whatever angle, the texts have a revelatory power that shines a light on the human condition, our sense of purpose, place in the world, and even our destiny. Born out of the common reflection on the history of single nation with a sense of divine election, the Bible has spoken, and continues to speak to all people in various circumstances, in words of such power that seem divinely inspired. This second volume looks at a more narrative view of the history of Ancient Israel, in stories written in the late Old Testament to reflect on the tribulations of the people in captivity, either after the Assyrian Deportation of 722 BC, the Babylonian Captivity (597 BC), during Persian rule (538-323 BC), or under the grave existential threat posed by the Greek Seleucid Syrians (167–163 BC). God's ways are sought amidst defeat and confusion, amidst fear and hope: his power to save out of suffering implored. The stories of Daniel, Jonah, Ruth, Esther, Tobit, Judith and the Maccabees remain parables of faith in God's providence, his redemptive love. This study encourages reading the texts themselves, developing a sharper perception of language, imagery, genre and style. The book, thus, provides an overall picture of the literary types employed, locates the sacred books in a chronological and thematic context, exploring the texts through the specific passages provided, always looking to find the theological keys critical to understanding these particular books and their enduring message across the ages. A particularly interesting aspect of this study is its collection of iconography, offering a cross-section of artistic responses to the power of the biblical discourse through the centuries. While Gustave Doré's famous etchings form the axis of the centrefolds, many other painters are included from different periods.
