



This book provides a comprehensive overview of this multi-disciplinary subject, which has interaction with other disciplines, such as mineralogy, petrology, structural geology, hydrogeology, seismic engineering, rock engineering, soil mechanics, geophysics, remote sensing (RS-GIS-GPS), environmental geology, etc.

This proceedings contains 89 papers from 25 countries and regions, including 14 keynote lectures and 17 invited lectures, presented at the Third International Conference on Geotechnical Engineering for Disaster Mitigation and Rehabilitation (3ICGEDMAR 2011) together with the Fifth International Conference on Geotechnical & Highway Engineering (5ICGHE), which was held in Semarang, Indonesia, from 18 to 20 May 2011. This is the third conference in the GEDMAR conference series. The first was held in Singapore from 12 to 13 December 2005 and the second in Nanjing, China, from 30 May to 2 June 2008. The proceedings is divided into three sections: keynote papers, invited papers and conference papers under which there are six sub-sections: Case Studies on Recent Disasters; Soil Behaviours and Mechanisms for Hazard Analysis; Disaster Mitigation and Rehabilitation Techniques; Risk Analysis and Geohazard Assessment; Innovation Foundations for Rail, Highway, and Embankments; and Slope Failures and Remedial Measures. The conference is held under the auspices of the International Society for Soil Mechanics and Geotechnical Engineering (ISSMGE) Technical Committee TC-303: Coastal and River Disaster Mitigation and Rehabilitation, TC-203: Earthquake Geotechnical Engineering and Associated Problems, TC-302: Forensic Geotechnical Engineering, TC-304: Engineering Practice of Risk Assessment and Management, TC-213: Geotechnics of Soil Erosion, TC-202: Transportation Geotechnics, TC-211: Ground Improvement, Southeast Asian Geotechnical Society (SEAGS), Association of Geotechnical Societies in Southeast Asia (AGSSEA), and Road Engineering Association of Asia & Australasia (REAAA).

The book presents the most noteworthy methods and results discussed at the International Conference on Reliability and Statistics in Transportation and Communication (RelStat), which took place in Riga, Latvia on October 16 – 19, 2019. It spans a broad spectrum of topics, from mathematical models and design methodologies, to software engineering, data security and financial issues, as well as practical problems in technical systems, such as transportation and telecommunications, and in engineering education.

This book presents a first-of-its-kind exposition on the emerging technology of jute fiber geotextiles. The book covers the characteristics of jute fiber and jute yarns, types and functions of jute geotextiles, and the mechanism of control of surficial soil with jute geotextiles. The content also includes applications such as the mechanisms of functioning of jute geotextiles in strengthening road sub-grade and controlling river bank erosion, stabilization of earthen embankments, management of settlement of railway tracks, and consolidation of soft soil by use of pre-fabricated vertical jute drains (PVJD). A chapter on soil basics is included to enable

clearer understanding of soil mechanisms. The book can be used as a reference work or as primary or supporting text for graduate and professional coursework. It will also prove useful to researchers and practicing engineers looking for a comprehensive treatise on jute geotextiles.

The book discusses different branches of geology, earth's internal structure, composition of the earth, hydrogeology, geological structures and their impact on terrain stability and solution of several engineering problems related with stability and suitability of site for construction. Starting off a new series on Transport Systems and Traffic Engineering the book aims to help bridge the gap between research and practice, encouraging a critical dialogue in different, specific, subjects spanning innovation, development and technology transfer. Those who offer innovation often do not meet the immediate needs of practitioners, especially in the traditional field of civil engineering. The papers forming this book are devoted to intersection control and safety and have been selected bearing in mind the criteria stated above. This rule holds for many different countries. Intersection crashes also represent a significant portion of serious injury crashes, and by right are receiving considerable attention from researchers and practitioners alike. This book is therefore devoted to relevant safety aspects of road intersections and innovative features in design and operations that may address the intersection crash problem. The thirteen papers are more or less equally devoted to roundabouts and signals. These papers cover many of the most recent and emerging issues related to intersection control and safety. Topics range from design details to driver perception, from pedestrians behaviour to signal timing, and from capacity models to red-light running. The book will be useful for those wishing to expand their knowledge of this ever important subject area.
